Note: Fees are billed quarterly to the Participant's brokerage firm following the initial join date.

3. Terms and Conditions of Participation

By signing below, the Participant agrees to the following terms:

- To comply with the Rules and Regulations and Bylaws of the Southwest Georgia MLS, as amended from time to time.
- That payment of dues constitutes ongoing agreement to comply with such rules and policies.
- That the Participant has access to said documents via the Navica MLS portal under the "Resources"
- → "Documents" section and may request a physical copy from the Board at any time.

The Participant further agrees to:

- Maintain the confidentiality of all MLS login credentials.
- Not share, distribute, or disclose MLS login or SentriLock credentials to any third party under any circumstance.
- Show property only in accordance with instructions provided by the listing agent.
- Maintain an active and current SentriLock and MLS account. Failure to maintain account standing may result in suspension of access.
- Immediately notify the Board/MLS within three (3) business days of any of the following:
- * Change in name, contact details, or company affiliation;
- * Suspension or revocation of licensure;
- * Termination from the current brokerage firm.

4. Penalties and Enforcement

- Unauthorized sharing of login or SentriLock access may result in a fine ranging from \$500 to \$1,000 and may include revocation of MLS access.
- Intentional compromise of the MLS system may result in termination of privileges and/or legal action to recover damages.
